The course is intended for those interested in obtaining the OMG Certified Expert in BPM™ 2 Fundamental certificate (OCEB 2, also known as BPM certification). Its content fully corresponds to the individual requirements for the exam. OCEB 2 Fundamental is the initial certification level, which is followed by the Intermediate and Advanced levels. It is important to note that this certification covers the entire discipline of process management (Business Process Management). The exam therefore does not only examine modeling in BPMN notation itself, but also broader managerial and organizational contexts.

Candidates interested in certification often assume that it tests exclusively BPMN. However, the OMG organization does not provide a separate exam focused purely on this notation. Therefore, our course will comprehensively and clearly guide you through all the necessary overlaps that the exam requires.
